- Entries must be postmarked by October 7, 2007. Entries postmarked October 8 - October 15, 2007 will be charged a late fee. No entries accepted after that postmark.
- Pending registrations will not be accepted.
- All alpacas entering the show grounds must show proof of a negative PCR test or a negative VI test for BVD.
- No refunds, substitutions or changes allowed after October 15, 2007
- A \$25.00 fee will be retained for all farm cancellations before October 15, 2007
- Stall prices include panels. Bedding will be provided for the stalls, and additional bedding will be available for purchase.. Maximum of 3 adults or 4 weanlings per stall.
- No stall limits per farm

All entries must be accompanied by a copy of the ARI registration certificate and Buyer's Permission to Show Form (if applicable) arranged in same order as below.
IF the ARI certificate has not been issued yet, the registration detail page from the ARI website is currently acceptable. The detail page needs to show the owner's name, all the alpaca information and the date registered. (One line per entry. Continue entries on Page 2 if necessary)
