- Electricity is available (you will need to supply a 50' construction grade electrical cord).
- If needed, tables and chairs can be provided: Tables are \$6 each, chairs are \$1.25 each.
- Displays may be set up as early as Wednesday, April 29, 12:00 PM, but no later than Thursday, April 30, 8:00 PM! **There will be no exceptions.**
- Drive-in is available for set-up.
